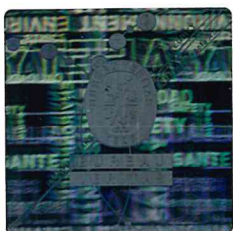

This component certificate only serves as a basis for the issuing of certificates for equipment or protective systems.

Further requirements of this Directive apply to the manufacture of this component and its placing on the market. Those requirements are not covered by this certificate.

(15) Description of component:

The build-in switch mini type 07-1501-****/**** is used as equipment or utility power switch for signal and control circuits. The connection is made by cemented single conductors.

(17) Notes for manufacture, installation and operation:

The build-in switch mini shall be used within its operating range and rating according to manufacturer's documents and marking.

The build-in switch mini must be installed inside of a housing which fulfills the requirements of an approved type of protection according to EN 60079-0. Resistance to light exposure is fulfilled by the housing material according to EN 60079-0. The specific installation standards and manufacturer's instructions must be respected.

The connection lines of the build-in switch mini must be protected against tensile load and torsion.
